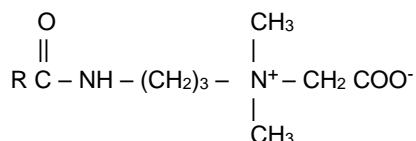

AMPHOSOL HCG-K is readily biodegradable. Additional information is available upon request.

Toxicity

AMPHOSOL HCG-K is slightly toxic orally (oral LD<sub>50</sub> rat > 1500 mg/kg).

Storage & Handling

Normal safety precautions (i.e., gloves and safety goggles) should be employed when handling AMPHOSOL HCG-K. Contact with the eyes and prolonged contact with the skin should be avoided. Wash thoroughly after handling material.



**Bulk Storage Information:** It is recommended that AMPHOSOL HCG-K be stored in sealed containers and kept at temperatures between 40 °F (4 °C) and 110 °F (43.3 °C). Avoid overheating or freezing. If material is frozen, mild heat and agitation are recommended to ensure the material is homogeneous before use.

**Standard Packaging:** AMPHOSOL HCG-K is available in bulk, totes and 55 gallon drums (net weight 450 lb/204 kg).
